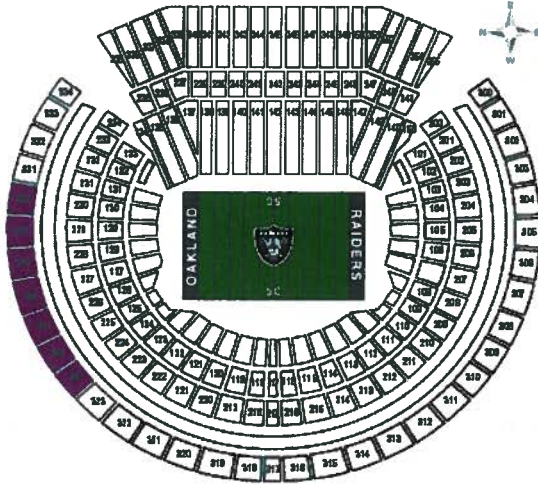

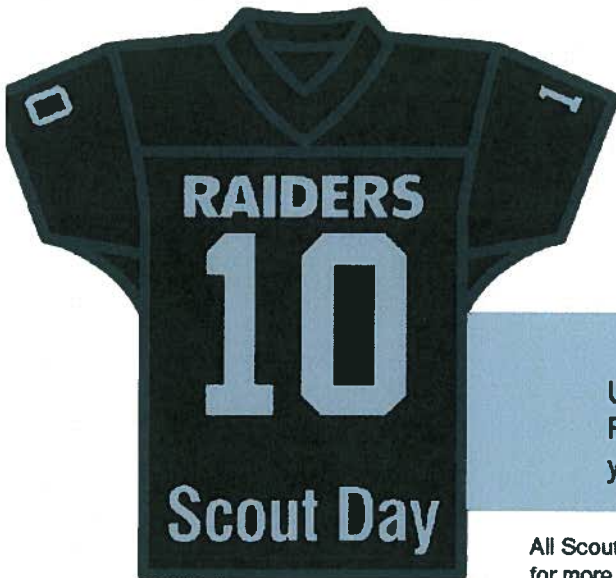

**ASSIGNMENT OF RIGHTS TO IMAGES, WAIVER, AND RELEASE REGARDING
HALFTIME AND GAME DAY ENTERTAINMENT PARTICIPANTS**

I _____ (hereinafter "Participant") desire to participate or compete in a halftime, pregame, post-game, or other game day performance, contest, or other entertainment activity (collectively "Event") related to an Oakland Raiders football game at or around the Oakland-Alameda County Coliseum ("Stadium"). Participant acknowledges that their participation will be recorded by pictures, video, and other media and Participant hereby irrevocably assigns, transfers, delivers and grants the Oakland Raiders and its agents, successors, contractors, and assigns (collectively "the Raiders"), all right, title, and interest (including all publicity rights) in any and all pictures, photographs, videos, or other images in any format taken of Participant by the Raiders ("Images"). Participant agrees that the Raiders may, *inter alia*, use, publish, copyright, and distribute the Images for any reason or purpose whatsoever, including, but not limited to, commercials, game programs, posters, billboards, scoreboard displays, and any other publicity or advertising media ("Promotional Materials"). Participant agrees that the Raiders may, as sole owner of the Images, enter into agreements with any other individuals, entities, or parties with respect to the Images and any Promotional Materials. Nothing in this agreement shall in any way restrict, limit or reduce the Raiders' rights to use the Images in any manner. Participant acknowledges that the Raiders have no obligation to use any of the Images for any purpose and that the manner and extent of any use of the Images shall be in the Raiders' sole discretion. Participant acknowledges and agrees that there will be no compensation of any kind or any other type of payment due in connection with the Raiders' use of the Images.

Additionally, in consideration for the Raiders' agreement to allow Participant's participation in the Event, Participant (or Participant's Parent if Participant is under 18 years of age) for Participant's self, family, heirs, personal representatives, assigns and insurers, hereby now and forever releases, waives, discharges, and covenants not to sue the Raiders and/or its past and present partners, limited partners, owners, entity owners (and the current and former officers, directors, shareholders, partners, members, limited partners and employees of any owners or entity owners), employees, agents, attorneys, directors, officers, shareholders, contractors, successors, assigns, subsidiaries, affiliates and insurers (collectively "Released Parties"), from of and for any and all claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions and causes of action whatsoever, of every nature, character and description, known, unknown, discovered, undiscovered, suspected or unsuspected (collectively "Claims") including, but not limited to any and all Claims arising out of or in any way related to the Event, Participant's participation in the Event, Participant's presence at the Stadium or in the parking areas or areas adjacent to the Stadium at any time, any prize or award related to the Event, the alleged negligence of any of the Released Parties, or any personal injury, accident, illness (including death) or property loss. Participant expressly waives the provisions of California Civil Code Section 1542 which provides:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.

In consideration for the Raiders' agreement to allow Participant's participation in the Event, Participant (or Participant's Parent if Participant is under 18 years of age) also agrees that at all times Participant will defend, hold harmless, and indemnify all of the Released Parties from and against any and all claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions, causes of action and liabilities of any kind or nature whatsoever (including reasonable attorneys' fees and disbursements) arising out of, in any way related to, or in any way connected with the Event, Participant's participation in the Event, Participant's presence at the Stadium at any time, any prize or award related to the Event, the alleged negligence of any of the Released Parties, or any personal injury, accident, illness (including death) or property loss.
